On motion by Trustee Cohen, seconded by Trustee Arnold and adopted unanimously, the Board approved the budgetary transfers as requested in the October 11, 2024 memorandum from the Village Administrator.

On motion by Mayor Natiss, seconded by Deputy Mayor Sgambati and adopted unanimously, the Board authorized the Mayor to enter into a consulting agreement with Katherine G. Solosky, for a period of one year commencing October 16, 2024 (with earlier termination provisions), at an hourly rate of \$19.00, in a form prepared by the Village Attorney.

The Board reviewed the most recent report on usage of the Village shuttle service.

The Board noted that the service continues to increase, and continues to be a service available and useful to all Village residents. The Board will continue to review usage.
